The following data is a survey of fossil fuel investments, including upstream, midstream, and downstream investments as well as fossil fuel-fired power generation by the largest private equity, private infrastructure, and energy-focused private equity managers by assets under management. Note: As private equity investments are often not disclosed publicly, the data inevitably contains errors or companies that have been exited. The data was gathered primarily using Pitchbook.
