Revenue cycle management remains a broad category

The companies include private equity-owned debt collectors, medical credit card companies, and "end-to-end" revenue cycle management companies – including companies which have placed high-interest debt onto patients unable to afford health costs or aggressively pursued patients unable to keep up with medical debts.<sup>2</sup>

PESP identified 113 companies from the *Becker's* list which are owned by private equity, or 28.5% of companies included on the list.
